Assignment Title: HIRING OF FIRMS FOR PROVIDING CONSULTANCY SERVICES FOR SCHOOL REHABILITATION ACTIVITIES

Interested Firms should provide information demonstrating that they have the required qualifications and relevant experience to perform the services.

Evaluation Criteria

1	Establishment of firm (age of firm and permanent office set up) (one score for one year)	10
2	Core managerial competency	10
3	General Experience: experience in professional services in providing consultancy services in education sector (5 scores for each assignment)	30
4	Specific Experience: experience of successfully implementing assignments of similar nature (5 scores for each assignment)	30
5	Financial Stability/Position: Audited Reports/Bank Statement for the last 4 years: 5 scores for each audited report:	20

Firm will be pre-qualified in accordance with the Punjab Procurement Rules (2014). The firm which will obtain 65 or more scores will be pre-qualified and only prequalified firms will be entitled to participate in the subsequent procurement proceedings for each of the three procurements.

A consulting firm may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.

Expression of interest must be delivered in a written form at the address below by 18th July, 2019 before 3.00 PM. The EOIs will be opened at 3.30 PM on the same day in the presence of the representatives of the firms.
